- 2) All bids in which any of the prescribed conditions is not fulfilled or any condition is put forth or conditional bids by the bidder(s) shall be summarily rejected.
- 3) Payment: 100% payment to be released within 15 days after activation of warranty extension pack, submission of tax invoice & AMC documents. The AMC information should be reflected on the official Epson portal.
- 4) EMD: Rs.4,700 (Rupees four thousand seven hundred only) to be deposited through online transfer mode to the below mentioned bank account & the transaction receipt (UTR No.) will be submitted by the bidder along with other required documents:

- 9) Liquidated Damage (LD): The successful bidder is required to supply and install all the items within 15 days w.e.f. the issue date of Purchase Order (PO).
