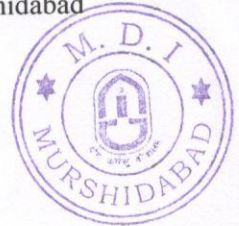

Annexure – I (Terms & Conditions)

- 1) The applicant shall be a firm/ company registered under the Indian Companies Act and who have their registered offices in India (Attached copy of Certificate of incorporation or any other relevant documents with GST certificate & copy of PAN card).
- 2) The firm should be in the business of providing similar services for at least 5 (five) years as on 01.01.2022.
- 3) The bidder should have executed at least 2 (two) similar nature of orders each of minimum of Rs.5 (five) Lakh or more in last 3 years.
- 4) The bidder should not be blacklisted/ debarred or involved in any corrupt & fraudulent practices by any Central/ State Govt./ PSUs/ Quasi-Govt. Organisations/ Autonomous Body/ Private Organisation in India.
- 5) EMD: Rs.10,000 (Rupees ten thousand only) to be deposited through online transfer mode to the below mentioned bank account & the transaction receipt (UTR No.) will be submitted by the bidder along with other required documents:

- 6) Payment: 100% payment will be released after satisfactory completion of the job and submission of tax invoice.
 - 7) Job Completion Period: Job should be completed within 30 days w.e.f. the issue date of Purchase Order (PO).
 - 8) Warranty & Support Service: Warranty will be as per existing OEM's Policy & it should be reflected on OEM's portal (Ruckus) and 1 (one) year (w.e.f. date of commissioning) remote & telephone support and as well as onsite support in case troubleshot not resolved through remote support for the equipments mentioned in this tender.
 - 9) Liquidated Damage (LD): The successful bidder is required to complete the job within 30 days w.e.f. the issue date of Purchase Order (PO). Delay in delivery will attract a penalty @1% of PO value (excluding GST) per week subject to a max. of 10%. Alternatively, the order will be cancelled.

10) Performance Security Deposit:

- a. The agency will be required to deposit security money equivalent to 5% of the total order value (exclusive of the GST) through Electronic Fund Transfer. Bank details have already been provided at clause-5 (share the UTR No after the transfer to track) within 15 days from the date of award of order.
 - b. The security money so deposited by the agency will be retained by the Institute till completion of the 1 (one) year support service period and will be released thereafter on claim subject to adjustment & without interest.
- 11) Installation Location: location: MDI Murshidabad, Vill. - Kulori, P.O. - Uttar Ramona, P.S. - Raghunathganj, Dist. - Murshidabad, West Bengal, PIN – 742235.
- 12) **Please ensure that Tender document must be signed and stamped on all pages as a token of acceptance of all the terms and conditions.**
- 13) **Sub contract is strictly not allowed, if found that sub-contracting have been done then the order will be summarily cancelled and no payment will be made to the vendor.**
- 14) The quoted price shall be valid for at least 60 Days. Institute will not entertain any request in respect of escalation of price due to any reason whatsoever during this time period. The charges quoted shall be kept firm throughout the pendency of contract of this work and no price escalation shall be entertained.
- 15) Existing Controller: Ruckus make SmartZone 100. All other devices mentioned in the tender should be successfully integrated with this WLAN Controller.
- 16) Bidder's Scope: (a) Project to be completed on turnkey basis and as per MDIM's satisfaction, (b) Project documentation to be provided after commissioning, (c) 1 (one) year (w.e.f. date of commissioning) remote & telephone support and as well as onsite support in case troubleshot not resolved through remote support, (d) The access points should be mounted on the ceiling or wall with standard mounting brackets and no additional cost to be paid by the Institute for mounting brackets, (e) Laying of Cat6 cables through required PVC conduit, (f) Configuration in WLAN Controller for addition of new access points.
- 17) In case any item is found to be defective/substandard, the same shall be rejected. Institute shall not make any payment for such items and shall be replaced immediately.
- 18) If the successful bidder fails to complete the job within due date as mentioned in the tender/bid documents, the EMD will be forfeited and MDIM will not entertain any request in this regard.
- 19) Institute reserves the right to accept or reject any or all the bids without assigning any reason whatsoever.
- 20) Any legal disputes will be subject to local court of Murshidabad district, West Bengal.
