- 3) Payment Terms: 100% payment to be released within 15 days after satisfactory completion of work and submission of tax invoice & license document.
- 4) Performance Security Deposit:
 - a. The agency will be required to deposit security money equivalent to 5% of the total order value (incl. of all) in the form of Online Fund Transfer within 15 days from the data of award of order.
