- Watershed management: The group supports programs to protect and restore watersheds, which are essential for water security. This includes afforestation, rainwater harvesting, and other measures.



#### **PRADAN**

Founded in 1983, PRADAN has evolved over the past three decades as one of the most prominent Indian NGOs working on poverty alleviation. It has built a track record of quality performance, deploying high-quality human resources to work in remote rural pockets with the poor. Their work with around four million people in 8,500 villages (and many more by partnering with government and other civil society organizations) gives us them confidence to systematically engage with poor communities to help them transform their lives at a large scale.



PRADAN has been at the forefront of innovations in rural livelihoods. With thematic expertise in agriculture, livestock, natural resource management and micro-enterprise promotion, their long-term partnerships with funders and institutions have enabled them to make a significant impact in rural India.

PRADAN has helped promote sectoral Institutions like Tasar Development Foundation (TDF) and National Smallholder Poultry Development Trust (NSPDT), for small landholders which are among the largest organised efforts in the country.

#### **PRADAN**

Besides economic empowerment, systematic engagement by their professionals embedded in the community has helped women from marginalized communities come together as strong collective forces, empowered to engage confidently in their households and with different stakeholders. PRADAN trains and places well-educated people with empathy at the grassroots, who support and engage with robust collectives of women, that strive for large-scale change in human condition.



PRADAN works with 764,539 families in 8,160 villages spread across 37 districts in 7 States, ~70% of who belong to most vulnerable groups such as Dalits and tribals (indigenous community). PRADAN's work has also received recognition through several prestigious awards, including the 'NGO of the Year' award in 2006 by Nand and Jeet Khemka Foundation, and the Resource Alliance Group. In 2009, Deep Joshi, the co-founder of PRADAN, was conferred the Ramon Magsaysay Award for his "pioneering work in rural communities"In 2015, PRADAN was awarded the Times of India (TOI) Social Impact Award in the Best NGO (livelihoods) category. In 2017, PRADAN was awarded the best social enterprise award by Business Standard



#### ROHINI NILEKANI

Born in 1960, Rohini Nilekani is an Indian author, writer, and philanthropist.[1] She is the creator of the non-profit Arghyam Foundation, which was established in 2001 and focuses on issues related to water and sanitation. In addition, she serves as chair of the elementary education-focused Akshara Foundation. She is the Rohini Nilekani Philanthropies' chairperson.



A philanthropist as well, Nilekani promised the Ashoka Trust for Research in Ecology and the Environment (ATREE) ₹50 crores. In August 2013, she raised approximately ₹164 crores for charitable purposes by selling 5.77 lakh Infosys shares. Forbes Magazine recognised her as one of Asia's Heroes of Philanthropy in both 2010 and 2014. She provides support to about eighty civil society organisations that deal with issues related to animal welfare, independent media, gender equity, and climate change. In March 2022, she took home the Best Grassroots Philanthropist award at the Forbes India Leadership Awards. She was granted the Associated Chambers of Commerce and Industry of India (ASSOCHAM) Philanthropist of the Year 2020–21 Award.

## G20 GREEN & SUSTAINABLE GROWTH CONFERENCE

- The G20 Tree Planting Ceremony on October 23, 2023, to symbolize the G20's commitment to sustainable development.
- The 1st P20 Summit under India's G20 Presidency on October 14, 2023, which brought together parliamentarians from G20 countries to discuss global issues.
- The launch of the G20 Inclusive Recovery Monitor in September 2023, which tracks progress on inclusive economic recovery across G20 countries.





The conclusions that we drew from this conference was the better results might result from using the G20 to speak for the Global South and by promoting attainable goals within the SDG framework. Sustainability should be viewed broadly to encompass human wellbeing rather than strictly economic activity. The problems caused by climate change require multilateral solutions, such as building resilience funds, de-risking platforms, fostering circular economies, working together on technical advancements, and strengthening partnerships for green energy security and transition.
